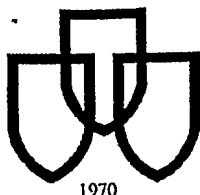

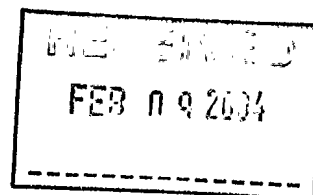

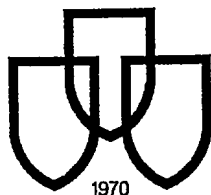

**INTENTION TO REPEAL A BY-LAW DESIGNATING  
THE "MOYER HOUSE"  
3443 RITTENHOUSE ROAD, VINELAND  
AS A STRUCTURE OF ARCHITECTURAL AND HISTORICAL VALUE**

In accordance with the Ontario Heritage Act, R.S.O. 1990, c.O.18, as amended, the Council of the Corporation of the Town of Lincoln hereby gives Notice that it intends to repeal By-law No. 92-18, being a By-law to designate the property known municipally as the Moyer House, 3443 Rittenhouse Road, Vineland, Plan M-2, Part Lot 227, R.P. 30R-2469, Part 2, in the Town of Lincoln, as being a structure of architectural and historical value or interest.

The Council of the Town of Lincoln will consider repealing By-law No. 92-18 as a result of a recommendation from the Town of Lincoln Local Architectural Conservation Advisory Committee (L.A.C.A.C.) due to "significant alterations to the Moyer House (circa 1866)".

Any person may object to the proposed repealing of the by-law by filing a Notice of Objection setting out the reason for the objection and all relevant facts, served upon the clerk at the address noted below, within thirty days after the date of publication of this Notice.
