SUBJECT: Crown Inn - 378-396 Devonshire Road

Take Notice that the City of Windsor intends to designate the property known municipally as 378-396 Devonshire Road (The Crown Inn) as a property of architectural and historic value or interest pursuant to Part IV of The Ontario Heritage Act.

The reasons for the proposed designation are:

- (a) first hotel built in Walkerville (1892)
- (b) fine example of Queen Anne style of architecture (hipped roof, balcony, arcading, semi-circular surround head, nine dormer windows, string course)


