NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Ridgetown intends to designate the property, including lands and buildings, known municipally as 38 Erie Street South as a property of architectural and/or historical value or interest under Part IV of The Ontario Heritage Act, 1974, S. O. Chapter 122.

Reasons for the proposed designation - This church was built between 1875 and 1877 on a site gifted by Mr. & Mrs. John Mitton. The church is of gothic styling and is built of red brick with white brick buttresses. The structure has a handsome tower and spire, 140 feet in height in the north corner and a roof of variegated shades of slate. The original cost including lot, sheds, fence and bell was \$14,500.00.

Portion to be designated - Exterior portion of original building.

Any person may, before the 3rd day of January 1986 send by registered mail or deliver to the Clerk of the Town of Ridgetown notice of his or her objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts. When a Notice of Objection has been received, the Council of the Town of Ridgetown will refer the matter to the Conservation Review Board for a hearing and report.

TAKE NOTICE that the Council of the Corporation of the Town of Ridgetown intends to designate the property, including lands and buildings, known municipally as 8 Erie Street North as a property of architectural and/or historical value or interest under Part IV of The Ontario Heritage Act, 1974, S.O. Chapter 122. Reasons for the Proposed Designation - This home was built by Mr. John Cooper in 1873. The home was then purchased by Mr. Robert Shaw, a prominent farmer of the area. It was then willed to his three daughters who were known for their Millinery Expertise. This home of victorian architecture is to be designated to maintain a house of historical significance.

Portion to be designated - The exterior facade.

Any person may, before the 3rd day of January, 1986 send by registered mail or deliver to the Clerk of the Town of Ridgetown notice of his or her objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts. When a Notice of Objection has been received, the Council of the Town of Ridgetown will refer the matter to the Conservation Review Board for a hearing and report.
