NOTICE OF INTENTION to Repeal By-law No. 3419-91

TAKE NOTICE That the Council of the Corporation of the City of Stoney Creek intends to repeal By-law No. 3419-91 entitled "A By-law to Designate the Property Known as 77 King Street West as Being of Architectural and Historical Value or Interest",

The property is described as Parcel B, Parcel C and Parcel A, Registered Plan 1049 designated as Part 3, on Plan 62R-11773 and Part of Lot 26, Concession 4 (abstract as Parcels 32 and 38, on Proposed Registrar's Compiled Plan Book H262A) designated as Parts 1 and 2 on Plan 62R-11773 in the City of Stoney Creek (formerly Township of Saltfleet) in the Regional Municipality of Hamilton-Wentworth.

The reason for the repeal is due to recent information being made known to Council that the shutters, one of the elements originally identified as being important to the preservation of The Battlefield House, were not part of the original structure, but added to the building within the past 25 years.

Any person may, within thirty days of the first publication of this notice send by registered mail or deliver to Joseph A. Brezina, Clerk of the City of Stoney Creek, notice of his or her objection to the proposed repealing by-law, together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the City of Stoney Creek shall refer the matter to the Conservation Review Board for a hearing.
