

CORPORATION OF THE TOWN OF AMHERSTBURG

BY-LAW NO. 2394

Being a By-law to repeal Schedule "A" (7) of By-law 1493, to remove the heritage designation from the structure at 187 Murray Street (Adriano Tonon Residence).

WHEREAS the Council of the Corporation of the Town of Amherstburg enacted By-law 1493 on September 26, 1977 designating certain properties of architectural or historical interest or significance pursuant to the provisions of the Ontario Heritage Act; and



WHEREAS the property at 187 Murray Street was so designated in Schedule "A" (7) to said By-law 1493; and

WHEREAS the Council of the Corporation of the Town of Amherstburg at its meeting on June 10, 1996 did adopt the recommendation of the Local Architectural Conservation Advisory Committee to grant permission to the owner of the property to demolish the Adriano Tonon Residence, pursuant to an application made under Section 34 of The Ontario Heritage Act, RSO 1990, Chap. O.18.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF  
THE TOWN OF AMHERSTBURG HEREBY ENACTS AS FOLLOWS:

1. That Schedule "A" (7) of By-law 1493 of the Town of Amherstburg be, and hereby is, repealed.
2. That the Clerk of the Town of Amherstburg be, and hereby is, authorized to do or to cause to be done all such manner of act or thing as may be required to give full force and effect to this By-law.
3. That this By-law shall come into force and take effect on the date of final passage hereof.
