





## NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE THAT the Council of the Corporation of the Town of Gore Bay intends to designate the property, including lands and buildings, at the following municipal address as a property of architectural and historical value or interest under Part IV of The Ontario Heritage Act, 1974, S. O. Chapter 122

## (b) **Reasons for Proposed Designation**

The jail and Jailer's residence are part of the court complex, which includes the Court House and Registry Office for the District of Manitoulin. The historic jail and residence is a valuable part of a group of limestone buildings of various sizes, design and uses. This simple but dignified building served as both the jail and the Jailer's residence for fifty-six years.

The Gore Bay jail and Jailer's residence was constructed in 1889 and is the only historical jail in the District of Manitoulin that retains its original features including jail cells and their fittings, wood trim, moulding and floors throughout the building,

Over the years, it has survived with the minimum of renovations and it retains the elegance, which is possessed when first built. This elegance is due to its sensitive siting which commands a distant view of the water, as well as the architect's skillful handling of proportions and materials.

All the stone is original. Externally, the building remains essentially the same as the original. The building is a hammer-dressed limestone with all the classical details executed in contrasting smooth ashlar.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Town of Gore Bay before the 4th day of March, 2002.
