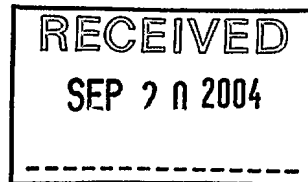

THE CORPORATION OF THE TOWN OF GRAVENHURST

BY-LAW NO. 2004- 143

Being a By-law to Repeal By-laws 91-83 and 91-84  
(Town of Gravenhurst)

WHEREAS under the Ontario Heritage Act, R.S.O. 1990, c. O. 18, Section 31, the Council of a municipality may repeal a by-law designating property as Architectural and Historical importance;

AND WHEREAS Council passed By-law 91-83 on May 21, 1991 in order to designate the Wheel House of the Steamship The R.M.S. Cherokee and By-law 91-84 on May 21, 1991 in order to designate the Wheel House of Steamship The R.M.S. Islander;


AND WHEREAS the Muskoka Steamship & Historical Society have requested the Town of Gravenhurst amend these by-laws in order to eventually permit the relocation of these two Wheel Houses in close proximity to the new Heritage Centre within the Muskoka Wharf Project;

AND WHEREAS Council passed Resolution No. 197 on July 20<sup>th</sup>, 2004 authorizing staff to proceed with the removal of the heritage designations during construction of the Muskoka Wharf Project.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF GRAVENHURST ENACTS AS FOLLOWS:

1. By-laws 91-83 and 91-84 be and the same are hereby repealed.

READ A FIRST, SECOND AND THIRD TIME and finally passed this 7th day of
