1. The Council of the corporation of the Town of Napanee intends to designate the following buildings in the Town of Napanee to be of historical significance.

1 (a) Town Hall; Lots 1,2 and 3 East of Centre Street and Lots 1, 2 and 3 west of John Street, known as 128 John Street. This building constructed in 1856 has served as the Towns Municipal Building since that date.

(b) Sandstone former Post Office; Lot 5 east of John Street known as 139 John St. Street known as 139 John St.
This building is of unique design and will shortly become a Community Centre for the Town. Built in 1888.
(c) County Buildings; Block 89; 87 Thomas Street E. (Social Services) 95 Thomas Et (Museum) and 97 Thomas Street E. (Court House and County Buildings) These buildings have served as These buildings have served as the County Seat in various capacities since 1864.
