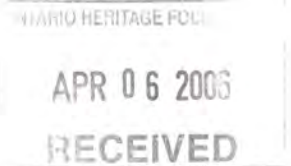

## TOWNSHIP OF CENTRE WELLINGTON

### BY-LAW NO. 2006-031

Being a By-law to designate 7003 Highway # 6  
in the former Township of Nichol,  
to be of Cultural Heritage Value or Interest

**WHEREAS** on the advice of the Municipal Heritage Committee, Council has been advised to designate the property noted below to be of cultural heritage value or interest to the provisions of the *Ontario Heritage Act*, R.S.O. 1990, c.O.18;

**AND WHEREAS** the provisions of Section 29, Subsections (1), (2), (3) and (4) have been complied with and no objection has been received by the Municipality.

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CENTRE WELLINGTON HEREBY ENACTS AS FOLLOWS:**

1. The lands and premises described as 7003 Highway No. 6, Plan 311, Lots 8, 9, 17 & 18, Part Lots 7, 16 & Mary St., Part Owen Sound Road, (Formerly Township of Nichol), now in Township of Centre Wellington are hereby designated to be a building of cultural heritage value or interest.
2. The reasons for the designation are as follows:

**Cultural Heritage Value or Interest:**


This single 1 ½ storey detached dwelling is estimated to be built in 1860 of a hand-made red brick in a stretcher pattern with occasional rows of common bond, end laid, and ornamental quoins of yellow brick. The windows are mostly 1 over 1 and feature segmental arches of yellow brick voussoirs with descending tabs. The front enclosed porch has been designed to repeat the segmental arches of the original windows.


**Heritage Attributes to be protected:**

Exterior red brick walls of red brick including the ornamental quoins of yellow brick and yellow brick voussoirs.


3. This By-law shall be registered against the title of the lands described as 7003 Highway No. 6, Plan 311, Lots 8, 9, 17 & 18, Part Lots 7, 16 & Mary St., Part Owen Sound Road, (Formerly Township of Nichol), now in Township of Centre Wellington.
4. This By-law shall come into force and take effect upon its final passing.
