TOWNSHIP OF CENTRE WELLINGTON

BY-LAW NO. 2006-031

Being a By-law to designate 7003 Highway # 6 in the former Township of Nichol, to be of Cultural Heritage Value or Interest

WHEREAS on the advice of the Municipal Heritage Committee, Council has been advised to designate the property noted below to be of cultural heritage value or interest to the provisions of the *Ontario Heritage Act*, R.S.O. 1990, c.O.18;

AND WHEREAS the provisions of Section 29, Subsections (1), (2), (3) and (4) have been complied with and no objection has been received by the Municipality.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CENTRE WELLINGTON HEREBY ENACTS AS FOLLOWS:

- The lands and premises described as 7003 Highway No. 6, Plan 311, Lots 8, 9, 17 & 18, Part Lots 7, 16 & Mary St., Part Owen Sound Road, (Formerly Township of Nichol), now in Township of Centre Wellington are hereby designated to be a building of cultural heritage value or interest.
- 2. The reasons for the designation are as follows:

Cultural Heritage Value or Interest:

This single 1½ storey detached dwelling is estimated to be built in 1860 of a hand-made red brick in a stretcher pattern with occasional rows of common bond, end laid, and ornamental quoins of yellow brick. The windows are mostly 1 over 1 and feature segmental arches of yellow brick voussoirs with descending tabs. The front enclosed porch has been designed to repeat the segmental arches of the original windows.

Heritage Attributes to be protected:

Exterior red brick walls of red brick including the ornamental quoins of yellow brick and yellow brick voussoirs.

- This By-law shall be registered against the title of the lands described as 7003 Highway No. 6, Plan 311, Lots 8, 9, 17 & 18, Part Lots 7, 16 & Mary St., Part Owen Sound Road, (Formerly Township of Nichol), now in Township of Centre Wellington.
- 4. This By-law shall come into force and take effect upon its final passing.
