TAKE NOTICE that the Council of the Corporation of the City of Vaughan intends to repeal By-law 187-85 and By-law 296-87 which designated the following property as property of architectural and historical value or interest under Part IV of the Ontario Heritage Act, R.S.O. Chapter O.18:

**REASON FOR PROPOSED REPEAL OF DESIGNATING BY-LAWS**

In 1999, a fire in the historic house known as the John Jeffery House, destroyed the structural components of the building, leaving the house in a condition whereby the historic and architectural significance of the building are considered destroyed. As a result, the By-laws which designate the house under the Ontario Heritage Act are being repealed to remove the historic designation against the property.

**NOTICE OF OBJECTION TO PROPOSED REPEAL OF DESIGNATING BY-LAWS**
