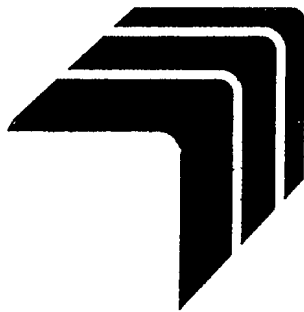



1. By-law No. 78-66, a by-law to designate the Weaver Homestead at 6590 Dunn Street of architectural value and historic interest, registered as Instrument No. 308788
2. By-law No. 78-67, a by-law to designate the Canadian Imperial Bank at 4190 Bridge Street of architectural value and of historic interest, registered as Instrument No. 308789
3. By-law No. 78-70, a by-law to designate the Oswald Residence at 2922 St. Paul Avenue of architectural value and of historic interest, registered as Instrument No. 308790
4. By-law No. 78-68, a by-law to designate the Church Residence at 3000 Portage Road of architectural value and historic interest, registered as Instrument No. 309563
5. By-law No. 78-69, a by-law to designate the Pohran Residence at 4891 Portage Road of architectural value and of historic interest, registered as Instrument No. 309564

To date the Municipal Council has designated ten buildings of historical or architectural significance within the municipality of Niagara Falls.

A by-law to designate the Church Residence at 3000 Portage Road of architectural value and of historic interest.

WHEREAS The Ontario Heritage Act, 1974, authorizes the Council of a municipality to enact by-laws to designate real property, including all the buildings and structures thereon, to be of historic or architectural value or interest;

AND WHEREAS the Council of The Corporation of the City of Niagara Falls has caused to be served upon the owner of the lands and premises municipally known as 3000 Portage Road, commonly known as the Church Residence, upon The Ontario Heritage Foundation, Notice of Intention to so designate the aforesaid real property and has caused such Notice of Intention to be published in a news paper having general circulation in the municipality once for each of 3 consecutive weeks;

AND WHEREAS the reasons for designation are set out in Schedule "B" hereto;

AND WHEREAS no Notice of Objection to the proposed designation has been served upon the Clerk of the municipality.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NIAGARA FALLS ENACTS AS FOLLOWS:

1. That the real property more particularly described in Schedule "A" hereto, known as the Church Residence at 3000 Portage Road be designated as being of architectural value or interest.
2. The City Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper Land Registry Office.
3. The City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon The Ontario Heritage Foundation and to cause notice of this by-law to be published in a news paper having general circulation in the City of Niagara Falls.

REASONS FOR DESIGNATION OF THE CHURCH RESIDENCE

This was the residence of Mr. Munson Church and was built early in 1800. It has undergone extensive renovation especially to the rear and interior of the home. However the north, west and south facades remain in excellent condition in the manner they were originally built. The home exhibits the very simple Georgian detailing of the time. It stands perhaps as a good example of a home that has been completely modernized without the complete destruction of style that usually accompanies such modernization.
