

Notice of Passing of By-law Designating the Barlow House

TAKE NOTICE THAT the Council of Corporation of the Township of Elizabethtown has passed By-law Number 96-21 to designate the property. including lands and buildings, known municipally as 18 Main Street West as a property of architectural value or interest under Part IV of the Ontario Heritage Act, 1974, S.O. Chapter 122.

A copy of By-law Number 96-21 is enclosed for your reference, along with the Reasons for Designation retained on file.

The Corporation of the Township of Elizabethtown By-Law Number 96-21

A By-Law to Designate Lands known as The Barlow House, 18 Main St. E., Part of Lot 29, Concession 3, Township of Elizabethtown, County of Leeds, as Being of Architectural Value or Interest.

Whereas section 29 of The Ontario Heritage Act, 1974 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest;

And Whereas the Council of the Corporation of the Township of Elizabethtown has caused to be served on the owners of the lands and premises known as The Barlow House at 18 Main St. E. and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in The Recorder and Times, a newspaper having general circulation in the Township of Elizabethtown, on the 14th day of September, 1996;

And Whereas no notice of objection to the proposed designation has been served on the clerk of the municipality;

Now Therefore Be It Enacted as a by-law of The Corporation of the Township of Elizabethtown as follows:

- That the real property known as The Barlow House at 18 Main St. E., described more particularly in Schedule A hereto attached, is designated as being of architectural value or interest.
- That this by-law shall be registered against the title of the property in the land registry office for the Registry Division of Leeds/Grenville (No. 28).
- 3. That a copy of this by-law will be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and that notice of the passing of this by-law to be published in The Recorder and Times, a newspaper having general circulation in the Township of Elizabethtown.
- That this By-law will come into force and effect upon the final reading thereof, and may be referred to as THE BARLOW HOUSE DESIGNATING BY-LAW.

Read a First and Second time this 15th day of October, 1996.

Read a Third time and finally Passed this 28th day of October 1996.
