

BY-LAW No. 908-2002

**To amend City of Toronto By-law No. 412-2000 regarding the heritage designation of
519 Jarvis Street (Chester D. Massey House).**

WHEREAS by By-law No. 412-2000, City Council designated the property at 519 Jarvis Street (Chester D. Massey House) as being of architectural and historical value or interest under Part IV of the *Ontario Heritage Act*; and

WHEREAS the legal description of the lands designated by By-law No. 412-2000 is attached to this by-law as Schedule "A";

WHEREAS the owner of these lands has applied to change the boundaries of the lands designated by By-law No. 412-2000;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. By-law No. 412-2000 of the City of Toronto is amended by:

- A. Deleting the words "and shown on Schedule "C" " from section 1.
- B. Deleting Schedule "B" attached to the By-law and replacing it with the following:
