PUBLIC NOTICE

NOTICE IS HEREBY GIVEN THAT THE COUNCIL OF THE CORPORATION OF THE CITY OF WATERLOO INTENDS TO DESIGNATE THE HEREINAFTER MENTIONED PROPERTY TO BE OF HISTORIC AND ARCHITECTURAL VALUE WITHIN THE MEANING OF SECTION 29 OF THE ONTARIO HERITAGE ACT, 1974.

THE HOUSE BUILT IN 1849 IS OF SIMPLE ARCHITECTURAL DESIGN COMBINING GEORGIAN AND GOTHIC INFLUENCES. SYMMETRICALLY PLACED SMALL PANED WINDOWS, RETURN EAVES, THE SEVEN PANED TRANSOM AND SIDELIGHTS OF DOORWAY AND SMALL ATTIC LEVEL WINDOWS SHOW THE GEORGIAN STYLE WHILE THE CENTRAL FRONT GABLE WITH THE GINGERBREAD BARGEBOARD INDICATES THE GOTHIC STYLE. FROM THE TIME OF ITS CONSTRUCTION TO 1871 THE BUILDING WAS USED AS THE HOUSE OF PRAYER AND WORSHIP OF THE EVANGELICAL CHURCH IN WATERLOO.
