THE CORPORATION OF THE CITY OF WATERLOO

BY-LAW NO. 83-10

BY-LAW TO DESIGNATE THE SNYDER-SEAGRAM
HOUSE, 50 ALBERT STREET, IN THE CITY
OF WATERLOO TO BE OF HISTORIC AND
ARCHITECTURAL VALUE AND INTEREST.

WHEREAS Section 29 of The Ontario Heritage Act, R.S.O. 1980, Chapter 337 authorizes Council of a municipality to designate property within the municipality to be of historic value or interest;

AND WHEREAS Council for The Corporation of the City of Waterloo deems it desirable to designate the Snyder-Seagram House, 50 Albert Street to be of historic and architectural value and interest;

AND WHEREAS the Clerk of the City of Waterloo has caused Notice of Intention to Designate to be given in accordance with Section 29(3) of The Ontario Heritage Act, R.S.O. 1980, Chapter 337;

AND WHEREAS no Notice of Objection has been served on the Clerk within the meaning of Section 29(5) of The Ontario Heritage Act, R.S.O. 1980, Chapter 337.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF WATERLOO ENACTS AS FOLLOWS:

1. The property described in Schedule "A" attached hereto is hereby designated to be of historic and architectural value and interest.
2. Section 33 of The Ontario Heritage Act, R.S.O. 1980, Chapter 337 shall apply only to the following exterior elevations of the Snyder-Seagram House located at 50 Albert Street, City of Waterloo:
 - (a) The West (front) facade of said house;
and,

(b) The North facade of said House;
and

(c) The South facade of said House.

3. This By-law shall come into effect on the final passing thereof by the Council of The Corporation of the City of Waterloo.

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the City of Waterloo, in the Regional Municipality of Waterloo and in the Province of Ontario and being composed of Lot 10 and Part of Lot 9, East of Albert Street, according to Registered Plan 491 for the said City of Waterloo and designated as PART 1 on a Plan of Survey deposited in the Registry Office for the Registry Office of Waterloo North (No. 58) as Plan 58R-3845.
