## PUBLIC NOTICE

NOTICE IS HEREBY GIVEN THAT THE COUNCIL OF THE CORPORATION OF THE CITY OF WATERLOO INTENDS TO DESIGNATE THE HEREINAFTER MENTIONED PROPERTY TO BE OF HISTORIC AND ARCHITECTURAL VALUE WITHIN THE MEANING OF SECTION 29 OF THE ONTARIO HERITAGE ACT, 1974.

THE SUBJECT PROPERTY IS MUNICIPALLY KNOWN AS 3 KING STREET SOUTH AND IS OWNED BY THE BANK OF MONTREAL.

THE BUILDING MADE OF CUT GREY STONE WAS BUILT IN 1914. IT WAS DESIGNED IN THE THEN POPULAR BEAUX ARTS TRADITION. CURVED PEDIMENTS, KEY STONES AND EARED TRIM ARE FEATURED ABOVE THE LOWER RANGE OF WINDOWS ON THE EAST SIDE.

ENGAGED IONIC COLUMNS ON EITHER SIDE OF THE RECESSED TRANSOM AND PLINTHS ABOUT THE BASE COMBINING WITH THE RECESSION OF FACADE PANELS RESULT IN A BUILDING OF HEAVY MASSIVE CHARACTER.

MOLSON'S BANK MERGED WITH THE BANK OF MONTREAL IN 1925 AND HAS ALWAYS BEEN A VIRTUAL MONUMENT ON KING STREET SYMBOLIZING THE IMAGE OF "THE BANK" HELD AT THAT TIME.
