NOTICE OF INTENTION TO DESIGNATE



March 4th. 1980

ONTARIO HERITAGE FOUNDATION

Take notice that the Council of the Corporation of the Village of Paisley, on the 7th. day of January 1980 decided to designate the building municipally known as "BRAESIDE" (The Scott House); as a property of historical and architectural value or interest under the Ontario Heritage Act. 1974 S.O. Chapter 122.

SHORT STATEMENT OF THE REASONS FOR THE PROPOSED DESIGNATION

Constructed to overlook the river on which he had arrived, this house was presented as a dowry by Samuel T. Rowe to Julia Putnam in 1880. The structure expresses the success of the pioneer as well as the elegance of a prominent matrimonial residence.

Decorative features - specially the gingerbread shutters, entrance portico and unique voussoir arrangements, provide a fine example of Gothic vernacular in a remarkable state of pre - servation. The designs for the porch on the west facade and the architrave of doors and windows in the south-west livingroom were copied from an American Pattern Book by M.F. Cummings and C.C.Miller(1868).

The site is part of Rowe's first subdivision and the building appears, by its proximity to the Rowe Home, the School(apartments) and the Church of Ascension, to have been part of a district developed under the careful surveillance of Paisley's second settler.

Notice of objection to the designation may be served in writing on the Clerk within 30 days of the 4th. day of March 1980.
