BY-LAW NO. 88-82

BY-LAW TO DESIGNATE THE HUETHER HOTEL LOCATED AT 59 KING STREET NORTH, IN THE CITY OF WATERLOO, TO BE OF HISTORIC AND ARCHITECTURAL VALUE AND INTEREST.

WHEREAS Section 29 of The Ontario Heritage Act, R.S.O. 1980 authorizes Council of a municipality to designate property within the municipality to be of historic value or interest:

AND WHEREAS Council for The Corporation of the City of Waterloo deems it desirable to designate the Huether Hotel located at 59 King Street North, to be of historic and architectural value and interest;

AND WHEREAS the Clerk of the City of Waterloo has caused Notice of Intention to Designate to be given in accordance with Section 29(3) of The Ontario Heritage Act, R.S.O. 1980;

AND WHEREAS no Notice of Objection has been served on the Clerk within the meaning of Section 29(5) of The Ontario Heritage Act, R.S.O. 1980.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF WATERLOO ENACTS AS FOLLOWS:

 The property described in Schedule "A" attached hereto is hereby designated to be of historic and architectural value and interest.

- 2. Section 33 of The Ontario Heritage Act, R.S.O. 1980 shall apply only to the East (King Street) exterior facade, excluding all signage, and the arched stone entrance and vaulted ceiling of the original storage cavern, now brewery.
- 3. This By-law shall come into effect on the final passing thereof by the Council of The Corporation of the City of Waterloo.

SCHEDULE "A"

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the City of Waterloo, in the Regional Municipality of Waterloo (formerly the County of Waterloo) and Province of Ontario and being composed of Parts of Lots 9, 10 and 11 on the West Side of King Street and Parts of Lots 10 and 11 on the East Side of Dorset Street in U.C. & E. Snider's Survey Registered Plan 491 which parts of land are more particularly described as all of Parts 1 and 2 as designated on Plan 58R-1698.

SUBJECT TO AN AGREEMENT as far as said Agreement affects the above described parcel of land outlining party wall and roof drainage rights according to Registered Instrument Number 15347.
