NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the City of Kitchener intends to designate the property at the following municipal address as a property of historic and architectural value under Part IV of The Ontario Heritage Act, R.S.O. 1980, Chapter 337.

The subject property is located at 1165 Doon Village Road and is owned by [REDACTED]. It is intended that in particular, the front and two side facades of the house, including the bracketing, the windows, doorway and chimneys, the flashed glass over the entrance door and in the transom from the dining room to the porch, the art glass in the transom from hall to living room and living room to dining room, the coloured glass in the stairwell with rondel of painted birds and flowers, and the marble fireplace will be designated.

The designation described herein is recommended due to the fact that this house, constructed in 1884, is representative of the Italianate influence so often chosen in the homes of industrial leaders of this area, because the Perine family was the founder of the first flax mill in the Dominion of Canada, and because the results of their industry are still evident in the community today.

Any person may, within thirty days of the first publication of this notice, send by registered mail or deliver to the Clerk of the City of Kitchener notice of his or her objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the City of Kitchener shall refer the matter to the Conservation Review Board for a hearing.
