**NOTICE OF INTENTION**

**TAKE NOTICE** that the Council of the Corporation of the City of Kitchener intends to pass a by-law to amend By-law 93-43 designation the former St. Jerome High School, consisting of the 1909 building (now municipally known as 45 College Street) and the 1909 building (now municipally known as 120 Duke Street West) both formerly known as 100 Duke Street West, as being of historic and architectural significance under Part IV of the Ontario Heritage Act, R.S.O., 1990, Chapter O.18, as amended. The amending by-law will remove the designation from the 1909 building recently destroyed by fire, and will apply the designation only to the 1907 building and property now known municipally as 120 Duke Street West.

Any person may send by Registered Mail or deliver to the Clerk of the City of Kitchener, Notice of his or her objections to the proposed amending by-law, together with a statement of the reasons for the objection and all relevant facts, to be received by the Clerk not later than the 11th day of April 2004. When a Notice of Objection has been received, the Council of the Corporation of the City of Kitchener will refer the matter to the Conservation Review Board for a hearing and report.
