**Re: Notice of Intention – 508 New Dundee Road**

Please be advised that the Council of the Corporation of the City of Kitchener at its regular meeting held Monday, March 23, 2015 passed the following resolution, namely:

“That pursuant to Section 29 of the Ontario Heritage Act, the Clerk be directed to publish a Notice of Intention to designate the property municipally addressed as 508 New Dundee Road, as being of cultural heritage value and interest; as outlined in Community Services Department report CSD-15-022.”

**NOTICE OF INTENTION**

**TAKE NOTICE** that the Council of the Corporation of the City of Kitchener intends to designate the following municipal address as being of cultural heritage value or interest under Part IV of the Ontario Heritage Act, R.S.O. 1990, Chapter O.18, as amended.

**508 NEW DUNDEE ROAD**

508 New Dundee Road is recognized for its design, physical, contextual, historic and associative values. The original stone farmhouse demonstrates design and physical value as a representative example of a mid-19<sup>th</sup> century Vernacular design with some elements influenced by Georgian and Classic Revival architectural styles. The original stone farmhouse exhibits a high degree of craftsmanship. Contextually, the property is physically and historically linked to its surroundings through its orientation to New Dundee Road. The property is associated with the theme of early English settlement, the Petworth Emigration Scheme and Ian C. Ormston. Ian C. Ormston was a Second World War veteran who was awarded with a Distinguished Flying Cross for his services by King George VI. Ormston's stewardship and care of the property have maintained the integrity of the original stone farmhouse.

The full particulars of the Statement of Significance are available in the Clerk's Office, 2<sup>nd</sup> Floor, Kitchener City Hall during normal business hours.

Any person may send by Registered Mail or deliver to the Clerk of the City of Kitchener, Notice of his or her objections to the proposed designation, together with a statement of the reasons for the objection and all relevant facts, to be received by the Clerk not later than the 27<sup>th</sup> day of April, 2015. When a Notice of Objection has been received, the Council of the Corporation of the City of Kitchener will refer the matter to the Conservation Review Board.
