Dear Mr. Leonard:

This is to advise that City Council, at its regular meeting held on May 11, 2015, passed the following resolution:

"That pursuant to Section 29(6)(b) of the Ontario Heritage Act, the Notice of Intention to Designate the property municipally known as 156-158 King Street West (former Hymmen Hardware building) be hereby withdrawn, as outlined in Community Services Department report CSD-15-057 to allow for the immediate and concurrent demolition of the building with 11 Young Street; and further,

That the Clerk be directed to serve a notice of the withdrawal on the property owner, as well as the Ontario Heritage Trust, and publish said notice in a newspaper having general circulation in the City of Kitchener."
