



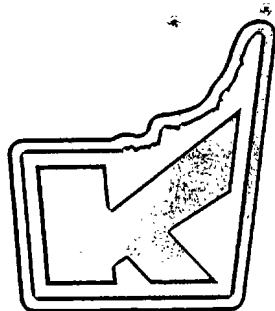

TAKE NOTICE that the Council of the Corporation of the Township of King has passed By-law Number 86-158 to designate the property, including lands and buildings, known municipally as Laskay Women's Institute Hall, Lot 20, Registered Plan 167 and being in Part of Lot 4, Concession 6, West side of Weston Road, Township of King as a property of architectural and historical value or interest under Part IV of the Ontario Heritage Act, R.S.O. 1980, Chapter 337.

REASONS FOR THE DESIGNATION:

The Laskay Women's Institute Hall was built in 1859 by a local division, No. 220, of the Sons of Temperance. Senator David Reesor donated the land upon which the old temperance hall was built. In 1910, the Laskay Women's Institute took over the hall. This simple, serviceable hall is one of the few remaining temperance halls in the area.

BY-LAW NUMBER 86-158

**A BY-LAW TO DESIGNATE THE PROPERTY KNOWN
MUNICIPALLY AS LASKAY WOMEN'S INSTITUTE
HALL, LOT 20, REGISTERED PLAN 167, AND
BEING PART OF LOT 4, IN CONCESSION 6,
TOWNSHIP OF KING, AS BEING OF ARCHITECT-
URAL AND HISTORICAL VALUE OR INTEREST**

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1980, Chapter 337 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural and/or historical value or interest; and

WHEREAS the Council of the Corporation of the Township of King has caused to be served on the owners of the lands and premises known as Laskay Women's Institute Hall, in part of the east half of Lot 4 in Concession 6, being more particularly Lot 20 as shown on Registered Plan 167, in the Township of King, and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and premises and has caused such notice of the intention to be published in the same newspaper having general circulation in the Municipality once for each of three consecutive weeks; and

WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the municipality;

THEREFORE the Council of the Corporation of the Township of King HEREBY ENACTS AS FOLLOWS:

1. THERE is designated as being of architectural and historical value or interest the real property known as Laskay Women's Institute Hall, on the west side of Weston Road in part of Lot 4, Concession 6, being more particularly described as Lot 20 as shown on Registered Plan 167, being the exterior only of the building and the immediate lands on which it stands.
2. THE municipal solicitor is hereby authorized to cause a copy of this By-law to be registered against the property described in Schedule "A" hereto in the proper land registry office.
3. THE Clerk is hereby authorized and directed to cause a copy of this By-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this By-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

APPENDIX TO BY-LAW NUMBER 86-158

REASONS FOR DESIGNATION OF LASKAY WOMEN'S INSTITUTE HALL

Lot 20, Plan 167, Township of King

The Laskay Women's Institute Hall is of historical significance because it was built by a local division, No. 220, of the Sons of Temperance in 1859. Senator David Reesor donated the land (part of lot 4 in Concession 6) upon which the Temperance Hall was built. In 1910, the Laskay Women's Institute took over the Hall.

The Laskay Women's Institute Hall is one of the few remaining Temperance Halls in the area. Its simple, serviceable style is typical of many halls built at that time.

The old Temperance Hall is still owned by the Laskay Women's Institute. The building is in good condition. The Women's Institute uses the hall for its meeting and occasionally for other community activities.
