### THE CORPORATION OF THE TOWN OF KINGSVILLE

#### BY-LAW 85-2012

Being a by-law to amend By-law 140-2011, being a by-law to designate a certain property, including land and buildings, known as The Adolphus H. Woodbridge House, as being of cultural heritage value or interest under the provisions of the Ontario Heritage Act, R.S.O. 1990, c.O18, as amended.

**WHEREAS** the property known as The Adolphus H. Woodbridge House, including lands and buildings was designated by By-law 140-2011 as being of cultural heritage value or interest under Part IV of the *Ontario Heritage Act*, R.S.O. 1990 c.O.18, as amended (the "Act").

**AND WHEREAS** Council of The Corporation of the Town of Kingsville deems it expedient to amend By-law 140-2011 to reflect the correct legal description respecting the Adolphus H. Woodbridge residence to only include Part 3 on Plan 12R-25120;

**AND WHEREAS** notice of this proposed amendment to By-law 140-2011 has been served on the owner of the aforesaid property and no notice of objection has been received within the time set out in the Act.

## NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF KINGSVILLE ENACTS AS FOLLOWS:

- That Schedule "B" attached to By-law 140-2011 be and is hereby deleted and replaced with Schedule "B" attached hereto and forming part of this By-law;
- 2. That a copy of this By-law be registered against the title to the property as described in Schedule "B" attached hereto, and that a copy of this By-law be served on those parties as described in the Act.
- This By-Law comes into force and takes effect on the day of the final passing thereof.

READ a FIRST, SECOND and THIRD TIME and FINALLY PASSED this 22<sup>nd</sup> day of October, 2012.
