#### NOTICE OF INTENTION TO DESIGNATE

IN THE MATTER OF THE ONTARIO HERITAGE ACT, RSO 1980, c. 337 s. 2; AND IN THE MATTER OF THE LANDS AND PREMISES AT THE FOLLOWING MUNICIPAL ADDRESS IN THE TOWN OF KINCARDINE, COUNTY OF BRUCE.

NOTICE IS HEREBY GIVEN that the Council for The Corporation of the Town of Kincardine intends to designate as property of historical or architectural value or interest, the following property for the following reasons:

PROPERTY: 286 - 290 Harbour Street South, Plan 61, Part Lot 2, Part Lot 3, Town of Kincardine, County of Bruce.

REASONS: The building was constructed in 1877 and has served as a centre of commerce on Harbour Street for over one hundred years. The building has been used as a bank, a barristers and solicitors office, a newspaper office, a doctor's office and a private residence. The building is architecturally significant for its intricate brick work design around the windows and parapet.

ANY PERSON who objects to this proposed designation may within thirty days after the date of first publication of this notice, serve on the Town Clerk, at the address listed below, a notice, in writing, setting out the objection and all relevant facts.
