**NOTICE OF INTENTION TO DESIGNATE**

**TAKE NOTICE** that in accordance with Section 29 of the Ontario Heritage Act, the Council of the Town of Mono intends to designate Maplehurst located at Part of the West Half of Lot 30, Concession 4, East of Hurontario, in the Town of Mono, in the County of Dufferin, in the Province of Ontario, and municipally known as 487242 30 Sideroad.

**REASONS FOR THE PROPOSED DESIGNATION**

Maplehurst is a good example of the Edwardian Classic style, popular between 1900 and 1930. Although common to urban areas, the Edwardian style is uncommon in rural settings such as Mono. Also uncommon was the purchase and transporting of the house to the present site from a nearby lot around the corner. This was a very unusual occurrence for the time. Maplehurst has typical features found in the Edwardian style. These include a square foot print with two rooms in the front, two in the back, exterior brickwork, a hipped roof with wide eaves, a dormer on the east façade, and a large front porch stretching across the front supported by four columns resting on brick piers.

The original heritage attributes to be preserved are as follows:

- symmetrical square two storey house with wide eaves;
- a dormer on east façade;
- Maplehurst plaque on east façade
- original brickwork;
- the front porch in its entirety, including brickwork, columns, roof, and saw-tooth decorative brickwork;
- all elevated sun porch including all fenestration;
- all doors, windows and associated hardware;
- all wainscoting;
- all wood floor and baseboard;
- all iron grates and registers;
- all components of the stairs including treads, risers, stringers, banister, balustrade, newel post; and,
- all mature maple trees fronting the entire property line along the south side of 30 Sideroad
