BY-LAW NO. 84-65

A BY-LAW TO DESIGNATE CERTAIN PROPERTIES TO BE OF HISTORIC

AND/OR ARCHITECTURAL VALUE OR INTEREST, PURSUANT TO SECTION

29 OF THE ONTARIO HERITAGE ACT

PASSED: March 1, 1984

WHEREAS Section 29 of the Ontario Heritage Act,

WHEREAS Section 29 of the Ontario Heritage Act,
R.S.O. 1080, Chapter 337 authorizes the Council of a
municipality to enact by-laws to designate real property,
including all buildings and structures thereon, to be of
architectural or historic value or interest;

276 Brock Street

This small stone cottage, with front gable, forms part of the Cathedral complex and its simplicity is in marked contrast to the major buildings.

132-134 Earl Street

This large stone, double house built in 1866 for Thomas Moore, was occupied by Moore for over twenty-five years, by Professor J.W. Williamson, brother-in-law of Sir John A. Macdonald, whose younger sister, Louisa, died here in November 1888.

5 Emily Street

John Power designed "Closeburn" for lawyer Thomas Kirkpatrick in 1854 as one of the three "cottage orne" adjacent to each other around the Emily-King corner. The Honourable Sir George A. Kirkpatrick, Lieutenant-Governor of Ontario, also occupied this house.

113 Johnson Street

This small, low-set, stone dwelling built about 1841, is typical of the sturdy and unadorned buildings which have been enlarged and improved over the years from 1854 through the 1940's.

228-230 Johnson Street

This handsome, double house with paired windows, stone balconies and decorative brackets was built to a design by William Coverdale for John Mowat, a founder of Queen's and father of Oliver Mowat.

261 Johnson Street - St. Mary's Cathedral

The cornerstone of this-Church was laid in September, 1843, the interior finished in 1851, stained glass windows installed in 1885 and the three front towers erected by 1892. G. Murray was the first architect; Joseph Connolly designed the facade. The Cathedral forms the dominant part of the complex.

279 Johnson Street - Archbishop's House

Built in 1849, this three and a half storey building provided a proper dwelling for the Bishop. Projecting from the rear of the house is a row of three connected buildings which provide office and work space.

53 King Street East

Built in 1841 for Mrs. Henry Murney, this symmetrical stone dwelling is, in the simplicity of its design, a contrast to the other buildings in this streetscape.

81 King Street East

This 1841 dwelling, built for John Watkins, hardware merchant and donor of the Watkins Wing at the hospital, was extensively remodelled for Joseph Upper in 1886. The design as well as the site create added interest in the streetscape.

"Earl Place" was built in 1851, likely designed by William Coverdale for Colin Miller, son-in-law of Captain Hugh Earl of the Provincial Marine, and husband of Ann Earl, daughter of Molly Brant and Sir William Johnson. For many years it was the residence of Dr. Orlando Sampson Strange and was then called Montague House.

203 King Street East

"Knaresborough Cottage" was designed by Thomas Rogers in 1834 for Mrs. Ann Macaulay, mother of the Honourable John Macaulay. It has undergone a number of alterations and additions, one by John Power in 1856. It remained in possession of the Macaulay family until 1947.

11 Ontario Street - Pump House Steam Museum

The first stone building on this site, erected in 1849 for the Kingston Waterworks Company, is now concealed by the 1890 building of Joseph Power built for the City of Kingston.

55 Ontario Street - Kingston Marine Museum

The stone building and massive chimney were built in 1890 by the Federal Government and Sir John A. Macdonald and Sir Hector Langevin came to Kingston to lay the "first" Dry Dock stone. The addition was erected in 1910.

167 Ontario Street

In 1886 William Newlands designed this station for the Grand Trunk Railway to replace an earlier small one. The L-shaped plan, the corner site and the design of this relatively small building increase its significance.

32, 36 and 40 Simcoe Street

This row of stone dwellings, originally a triple house, was built for John P. Bower, as rental property in 1842. It is the dominant aspect of this streetscape.

82 Sydenham Street - Sydenham Street United Church

This Church, designed by William Coverdale, was started in 1851 and the fine tower with slender spire was added in 1854. Extensive interior work was done in 1878 to plans by John Power.

126 Wellington Street

This remarkable Gothic church was designed by John Power for the Congregationalists in 1864. In 1891 fire damaged the interior of the church and the building was restored and enlarged with transepts to plans by J.B. Reid, superintended by Arthur Ellis. In 1923 the Masonic Lodge bought the property.

23-25 West Street

This double house, built in 1842, as rental property for Henry Gildersleeve, was tenanted for many years by government officials.

207 William Street

James Morton, distiller, had this double house built in 1846 as rental property and leased it to Queen's College in 1847. It was damaged by fire in 1849 and rebuilt under directions from the college. After 1854 it was again occupied as a double house, one half as a boarding house.

This 1875 building, designed by John Power for James Minnes, with later alterations by William Newlands, is an important visual focus at the end of Gore Street.

Barrie Street - Chalmers United Church

In 1889 Architects Gilen and Gilen, successors to Robert Gage, designed this church with its distinctive round tower for a congregation which had occupied a smaller building at Sydenham and Earl Streets.

66-68 Earl Street

This 1842 double dwelling built for James A.G. McDonald, with wide arched entrances and recessed windows above, is an interesting variation from Kingston architecture of the period.

98 Earl Street

An important part of the streetscape, this 1842 dwelling retains its original windows, shutters and fine entranceway.

100-102 Earl Street

This 1841 corner building, with fine proportions of parapeted end walls rising to twin chimneys, is an excellent example of buildings erected in Kingston's capital period.

114 Earl Street

William Coverdale designed this cottage for Charles Greenwood and Scobell built it over a three year period, an unusual length of time for the building of this distinctive dwelling.

195-197 Earl Street

This double, stone dwelling with brick facade, was listed in 1855 as unfinished and owned by James Renton, a builder. The western half retains the original, handsome entrance. .../4

This large, stone, double house, beautifully sited on the lakeshore, designed by John Power, is the finest example of its kind in this area. The Honourable John Hamilton had it built for his son and daughter.

76-78 Gore Street

Built as a single dwelling in 1842, the architect Coverdale converted it to a double house in 1845 for its owner William Denn. The conversion was typical of property owners' adjustments to the loss of the capital.

This building, with two entrances on Gore and one on Wellington, probably designed by George Browne, is one of the properties built for John Watkins and Samuel Muckleston, merchants, as real estate ventures during Kingston's capital period.

90 Johnson Street - Anglican Diocesan Centre

William Coverdale designed this handsome 1851 dwelling for James A. Henderson, barrister and later a judge.

121 Johnson Street - Greek Orthodox Church

In 1882 architect Robert Gage designed this building for the Baptist congregation. The ornamental facade rises high to hide the gable roof, giving the effect of a "boom-town" front. Recent additions have been designed to complement the original building.

150-152 Johnson Street

89-91 Gore Street

This double, stone dwelling, the first of a series of double houses on Johnson Street, is important to the streetscape and to show the development of rental housing. Built by Samuel Phippen as rental property in 1842, it was still untenanted when the capital left Kingston.

160-162 Johnson Street

This 1850 double dwelling, likely designed by architect John Grist, shows the development of larger window areas decorated by dripstone mouldings.

186 Johnson Street

This 1850 single dwelling built by Thomas Rudd, very similar to 166-168, is an integral part of the streetscape.

218 Johnson Street

This well-proportioned, roughcast, dwelling built before 1852, was the property of Dr. John Robinson Dickson, who served as coroner, alderman, Dean of Medicine at Queen's and Medical Superintendent of Rockwood.

222 Johnson Street

Dr. John R. Dickson had this large stone dwelling built in 1860, similar in scale to the double house west of it and likely designed by the same architect, W. Coverdale.

231-233-235 Johnson Street

In 1885+ a series of triple dwellings was built on this newly subdivided land to constitute a streetscape consistent in design, scale and materials sympathetic to the earlier stone houses opposite. William Newlands was the architect.

237-239-241 Johnson Street

This row of gentlemen's residences designed by W. Newlands for John Ward, was built in 1887-1888 to extend the streetscape of late 19th century brick dwellings.

31 King Street East

3

This is the central one of the three "cottage orne" erected in 1853-54 to plans by John Power and is doubly important because of its corner site.

45 King Street East

This third "cottage orne" has individual decorative details and enhances the interest of this important streetscape. It was built for Captain William Bowen to plans by John Power.

49 King Street East

This brick 1879 dwelling, designed by Joseph Power for Edward John Barket Pense, is an interesting contrast in style and material to the earlier stone houses beside it.

85 King Street East

This Victorian mansion designed by John Power and Son, was built by Richard Tossell in 1877 for Rybert Kent, who was for twenty years, proprietor of the British American Hotel. The three storey stone dwelling has some of the finest ironwork and carpenter work trim in Kingston.

95 King Street East

This high Victorian brick corner house designed by Joseph Power for James A. Hendry, was built in 1886. It is an excellent example of the height of asymmetrical design, variety of roof heights and design details.

161 King Street East

This symmetrical red brick dwelling was built for Noel Kent in 1873, to the design of his father-in-law, John Power.

165-167 King Street East

In 1858 Richard Cartwright (later Sir Richard) commissioned William Coverdale to design this double brick dwelling as rental property. The house has the distinctive Coverdale window design and with typical Coverdale fanlights is a good example of this architect's work.

169 King Street East

This 1885 brick dwelling, designed by William Newlands for banker Donald Fraser, presents, with other houses in this block, a study in the design and ornamentation of brick houses over a quarter of a century and compares the work of three Kingston architects.

This two storey brick dwelling, built in 1853 for Robert Sellars, is an important part of the streetscape.

202 King Street East

This small brick house built by Duncan Sinclair, shipwright, in 1841, has been altered but is important because of the abutting properties.

208 King Street East

This attached and altered early dwelling forms an integral part of the streetscripe.

212-214 King Street East and 46 Earl Street

This stone two-storey corner dwelling, built in 1843 for Edmund Boyle, is an important part of the streetscape of two streets.

254-256 King Street East

This is another William Newlands house, the earliest in this block built in 1889-1890. Dr. Clements also owned this property which he sold in 1902 to Dr. Alex W. Richardson.

75 Lower Union Street

"Charles Place" was built about 1828, likely designed by Thomas Rogers for James Nickalls and left to Charles Oliver. This fine Regency stone cottage, with its deep umbrage (recessed central porch) is most unusual in Kingston.

115 Lower Union Street

This substantial brick house on an important corner, facing City Park, was designed by John Power and built in 1856 for Judge Kenneth McKenzie. From 1864 to 1929 it belonged to the Macnee family, James Macnee, merchant and his heirs.

73 Sydenham Street

In 1888 John McKay, a leather and fur merchant, built this large corner residence. The tower and noteworthy terra cotta panels are excellent examples of the design of the period.

86-88 Sydenham Street

This double dwelling and Nos. 92-94 are examples of how a much later addition can complete the symmetry of a property. Number 88 was built in 1858 as a single family dwelling to designs by John Power for Stephen Irons. In 1879, Power and Son designed No. 86 for Joseph Power.

92-94 Sydenham Street

The corner property in this row of two double houses was built by 1857 for Stephen Irons, a hotel owner, to the design of John Power. The pair of brick, double dwellings form a major part of this corner streetscape.

25-27 Wellington Street

This double stone building is an example of the work of architect John Grist, who built number 27 in 1851, then added number 25 in 1854-55.

47 Wellington Street

The Wellington Street School, architect John Power, was built in 1873 to provide proper quarters for a school which had held classes in an old furniture warehouse. This is an excellent example of a fine building being put to a new use

96 Wellington Street and 70 William Street

Built in 1841 for Captain Charles Burns, this corner building is unusual for that period because of its three storeys. Its corner site adds to its significance.

118-120 Wellington Street

This double stone house was built in 1867-1868 by and for George Newlands, builder and father of William Newlands, who received some of his training in John Power's firm.

65 West Street

This brick corner house, part of a whole block of brick dwellings, was built in 1879 after Westbourne Terrace was completed. The round corner tower, bay window and central two-storey umbrage are notable aspects of architecture of the period.

112 William Street

This is one of the few houses in Kingston with an overall pattern of light brick against red. It was built by 1857 for William Brown who advertised it for rent.

129 William Street

This typical Ontario cottage, built of limestone and decorated with Gothic bargeboards was built about 1869 in a style popular almost twenty years earlier.

185 William Street

Built in 1855 for and by architect James Stewart; this brick dwelling has a number of details which give it special significance, especially for its period. The two-storey umbrage, detail of the trim, iron cresting and decorative chimney pots are all notable.

203-205 William Street

George Browne, architect of Kingston's City Hall, built this house as his private dwelling and office in 1841 and advertised it for sale in February, 1844. Queen's College leased the building in September 1844 and continued to use it after 1854 as their preparatory school until 1862.

5 Clergy Street East - Sydenham Public School

In August 1853, classes of the Kingston County Grammar School were opened in this building and in 1872 it became the Collegiate Institute. It was rebuilt after an 1876 fire with a new rear wing, to plans of Robert Gage.

178-180 Johnson Street

William Coverdele designed "Greystone Manor" in 1843 and Thomas Askew, who owned the property for many years, had as his most famous tenant John A. Macdonald, from 1849 to 1852. Macdonald's son, Hugh John, was born there.

194 Johnson Street

Charles Myers built this 1842 roughcast dwelling for Alfred Todd, a clerk of the Legislative Assembly. Later, when William Craig owned the property, he let it for three years (1857-1860) to John A. Macdonald's mother. John A.'s first wife Isabella died here, and her funeral was from this house in December, 1857.

211 Johnson Street - First Baptist Church

This stone church started in 1904 at the north end, was finished in 1913, then was gutted by fire in 1966 and rebuilt in its original style.

260 Johnson Street

This corner dwelling built in 1852 for Dr. George Baker, has undergone many changes, but is important for its siting, its scale, and some of its residents. Dr. John Stewart, secretary of the Medical Faculty at Queen's and editor of the Argus lived there.

Johnson Street - St. James Chapel

Built about 1889 to designs by J. Connolly, the chapel commemorates the raising of Kingston to an archdiocese and is attached to the northwest corner of the Cathedral.

Richardson Bath House - Macdonald Park

This bath house was built to plans of B.H. Prack of Toronto as a gift of Captain George Taylor Richardson. He was killed in 1919 and his brother and sister added funds to enable the bath house to be erected that year.

13 Maitland Street

"Saints Rest", a large stucco building, was built for John Plant Bower about 1830 near his tannery. Enlarged during the capital period, it had from then on a series of tenants; in the 1890's it was given its present name by the male boarders. In 1906 the Kingston Yacht Club acquired the property.

16 Maitland Street

This row of stone buildings, originally stables, carriage house and servants quarters, now apartments, is all that remains of Maitland House, built for the Honourable John Hamilton.

123 Sydenham Street - Hotel Dieu Hospital

The central section of the hospital was built in 1838-1842 to be a Roman Catholic Seminary. Regiopolis College occupied the building from 1842 to 1869. In 1891 the Sisters of the Religious Hospitallers of St. Joseph moved here from across Brock Street.

53-55 William Street

The placement of this double cottage, far back from the street, provides interesting variety to the streetscape. Built for Henry Gildersleeve before 1830, it was added to in 1843 when the west part of Number 55 was built. Number 53 is remarkably unaltered.
