NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE THAT THE COUNCIL OF THE CORPORATION OF THE TOWN OF HEARST INTENDS TO DESIGNATE THE LANDS AND BUILDINGS LISTED HERETO FOR THE STATED REASONS, AS PROPERTIES OF ARCHITECTURAL AND/OR HISTORICAL VALUE OR INTEREST, PURSUANT TO THE ONTARIO HERITAGE ACT R,S,O, 1980,

1. FORMER HALLE RESIDENCE

This property is recommended for designation because of historical and architectural reasons. Recently purchased by **Example**, the house in located on Part 3, Plan M98C, Parcel 10718 CC. This building is of Anglo-Norman style, very popular in the 1920's. It was the residence of the late Mr. Michel Hallé who was the developer of what was once known as Louisbourg, which is now incorporated with the Town of Hearst.

2. CANADIAN NATIONAL RAILWAY STATION IN HEARST

This property is recommended for designation because of its historical and architectural value. The building was constructed in 1912 and is one of the oldest in Hearst. Its style is typical of Canadian National Railways stations anywhere. It was the point of arrival of settlers coming to Hearst in that era as well as the focal point around which the first establishments were constructed.

3. GROTTO AND PARK NEAR HEARST COLLEGE

This structure and land is recommended for designation because of its historical value. The land affected is Lots 481, 482 and 483 of Plan M48A, being part of Parcel 4566 CC.

The Grotto was built by the Sisters of Perpetual Help in Hearst. This congregation no longer has members in Hearst. They played a very important role in the development of the educational system in Hearst.

4. ST. PAUL'S CHURCH - 28 NINTH STREET, HEARST

This building, situated on Lot 353, Plan M48A, Parcel 493 CC, is recommended for its historical and architectural value. It is the first and only church of the United Church persuasion to be constructed in Hearst. Its square-shaped turret is typical of most United mission churches.

5. ST. MATTHEW'S CHURCH - CORNER of NINTH AND PRINCE STREET

This building, located on part of Lots 334 and 335, Plan M48A, Parcel 3217 CC is recommended for designation because of historical and architectural reasons. It is the first and only Anglican Church built in Hearst. Its simple and functional style is typical of the frontier-style Anglican church of that era.

6. INDUSTRIAL BURNER - ALONG RAILROAD TRACKS (UNITED SAWMILLS)

This structure is recommended for designation because of historical and architectural reasons. This type of Burner is no longer permitted and therefore it is one of the last of its kind to be built. It is also a landmark typical of lumber towns such as Hearst. It is situated on a CN Lease No. L62084.

7. HOUSE ALONG HIGHWAY NO. 583 SOUTH

This house is recommended for designation because of its historial and architectural value. It is located on part of Lot 1, Concession 9, Way Township, Plan No. CR 316, Parts 3 and 4 and part of Part 2, Parcel 6300 CC.

It was the residence of Mr. Louis Camiré, one of the pioneer settlers in Hearst. The house is constructed in a style that was very popular in the 1920's.

8. HOUSE SITUATED AT 811 PRINCE STREET - HEARST

This house is recommended for designation because of its architectural value. It is located on Lot 341, Plan M48A, Parcel 2881. It is one of the rare houses of Anglo-Saxon style constructed in Hearst.

9. THE FACADE OF THE BUILDING AT 13 NINTH STREET AND THE STRUCTURE AT REAR OF SAME PROPERTY

The above are recommended for designation because of architectural reasons. They are located on Lots 270 and 271, Plan M48A, Parcel 780CC.

The facade of the building is of the "Boom Town" style, one of the few of its kind in Hearst. The building at the rear was built of square timber logs, characteristic of the type of pioneer construction in Hearst during that era.
