

THE CORPORATION OF THE TOWN OF HEARST

BY-LAW NO. 65-87

Being a By-law to designate properties in the Town of Hearst as being of architectural and historical value or interest.

WHEREAS The Ontario Heritage Act, Chapter 337 of the R.S.O. 1980, authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value or interest;

AND WHEREAS the Council of the Corporation of the Town of Hearst is the owner of the land and premises, listed on Schedule A to this by-law, and intends to so designate the aforesaid real properties and has caused a notice to be published in newspaper having general circulation in the municipality once each week for three consecutive weeks;

NOW THEREFORE BE IT ENACTED by the Council of the Corporation of the Town of Hearst as follows;

1. THAT the real properties listed on Schedule A attached hereto and forming part of this by-law, be and the said real properties are hereby designated as being of historical and architectural value.
2. THAT the Clerk shall cause a certified copy of this by-law to be registered in the Land Registry Office at Cochrane against the properties described in Schedule A of this by-law.
3. THAT the Clerk shall cause to be served on the Ontario Heritage Foundation a certified copy of this by-law.
4. THAT the Clerk shall cause notice of the passing of this by-law to be published in newspapers having general circulation in the municipality once each week for three consecutive weeks.
5. THAT the properties designated under this by-law shall not be altered where the alteration is likely to affect the reason for the designation unless Council consents by resolution to such alteration.
6. THAT no building or structure designated under this by-law shall be removed or demolished unless Council consents by resolution to such demolition or removal.
7. THAT this by-law shall come into force and take effect on the date of its final passing.

SCHEDULE A

TO BY-LAW NO. 65-87

Land and premises designated as being of historical and architectural value:

A monument being in the Town of Hearst in the District of Cochrane and more particularly described as the main monument in the Mgr Pierre Grenier Cemetery, located on Part of the south part of lot 1, Concession 10, way Township: Parcel 802 Centre Cochrane.

The land for the cemetery where this monument is located was purchased in January 1925 by the Roman Catholic Episcopal Corporation for the Diocese of Hearst. It became a public cemetery in 1976 and ownership was transferred to the Municipality in 1981. The central main monument was erected in the cemetery in June of 1925. It is the first major monument erected by the Diocese in the cemetery.
