#### BY-LAW 92-76

# A By-law to designated the property known municipally as 29 Regent Street, Lindsay, Ontario as being of architectural value or interest.

WHEREAS the Ontario Heritage Act R.S.O. 1990, Chap. 0.18, Section 29(6)(a), provides that the Council of a municipality may pass a by-law designating a property within the boundaries of the municipality to be of architectural value or interest, and

AND WHEREAS Notice of Intention to Designate the property municipality known as 29 Regent Street, Lindsay, Ontario has been given in accordance with Section 29(3) of the said Act, and

AND WHEREAS no objection to the proposed designation has been served on the Clerk of the Municipality.

AND WHEREAS this Council's reasons for the proposed designation are set forth in Schedule "B" attached hereto;

NOW THEREFORE the Council of the Corporation of the Town of Lindsay enacts as follows:

- 1. There is designated as being of architectural interest or value the exterior and interior features of the property known as 29 Regent Street, Lindsay, Ontario, more particularly described in Schedule "B" attached hereto. This designation shall not preclude any changes that may be deemed necessary for the efficient use of the building but that any and all such changes shall be in keeping with the original and present character of the building and in consultation with the Local Architectural Conservation Advisory Committee.
- The Municipality is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper land registry office.
- 3. The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation, and to cause notice of the passing of this by-law to be published in the Lindsay Daily Post once for each of three consecutive weeks.
- This by-law shall come into force and take effect on the final passing thereof.

### **REASONS FOR DESIGNATION:**

This pre 1875 house is recommended for designation for architectural and contextual reasons. This is a two-storey house built of yellow brick veneer construction with a rubblestone foundation. It features a low hip roof and decorative corbelled brick ornamentation over the windows. The sills are original. New windows have been added, sympathetic to the style...six over six, double hung. A sympathetic but modern verandah runs across the front of the house on the north face. The solid wood door is original and has a transom and two side lights with non original stained glass.

A new board and batten addition has been added to the south.

One of the first houses on Regent Street, this house is shown in the 1875 "Bird's Eye View of Lindsay" - it is an integral part of the streetscape which includes houses of similar design.
