BY-LAW 99 - 18

Short Title **A by-law to repeal By-law 54-89 designating the property at 435 Kent Street West as being of architectural value or interest.**

1. PREAMBLE:

Rationale 1.1 **WHEREAS** the *Ontario Heritage Act* c.O18, R.S.O. 1990 authorizes the Council of a municipality to designate property as being of historic or architectural value;

Rationale 1.2 **AND WHEREAS** the Council of the Corporation of the Town of Lindsay has passed By-law 54-89 designating the property at 435 Kent Street West as being of historic or architectural value;

Rationale 1.3 **AND WHEREAS** pursuant to section 34(1) of the *Ontario Heritage Act* c.O18, R.S.O. 1990; the Victoria County Historical Society, has applied to Council and received consent to remove the log cabin situated on the property at 435 Kent Street West;

Rationale 1.4 **AND WHEREAS** pursuant to Section 34(5) of the *Ontario Heritage Act* c.O18, R.S.O. 1990 Council is required to pass a by-law repealing the by-law or part thereof that designated the property at 435 Kent Street West;

Enactment 1.5 **NOW THEREFORE** the Council of the Corporation for the Town of Lindsay enacts as follows:

2. REPEAL OF BY-LAW 54-89:

Repeal of By-law 54-89 2.1 By-law 54-89 is hereby repealed.

3. FORCE AND EFFECT:


In Force on Passing 3.1 This By-law shall come into force and take effect on the final passing thereof:




