OF ALMONTE

BY-LAW NUMBER 3. - 1984

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS BLOCKS F. C. H. ALMONTE ONTARIO, AS BEING OF ARCHITECTURAL AND HISTORICAL VALUE OR INTEREST.

WHEREAS section 29 of The Ontario Heritage Act, R.S.O 1980 authorizes the Council of a municipality to enact by-laws to designate real propert including all buildings and structures thereon, to be of architectural or historic value or interest; and

WHEREAS the Council of the Corporation of the Town of Almonte has cause to be served on the owners of the lands and premises known as Blocks F,G

in the Town of Almonte and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and

WHEREAS no notice of objection to the proposed designation has been ser ed on the clerk of the municipality;

THEREFORE the Council of the Corporation of the Town of Almonte enacts as follows:

- The municipal solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in the proper land registry office.
- 3) The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-la to be published in the same newspaper having general circulaiton in the municipality once for each of three consecutive weeks.
