NOTICE OF INTENTION TO DESIGNATE.

TAKE NOTICE that the Council of the Corporation of the Village of Fenelon Falls intends to designate the properties - buildings and parts thereof, at the following municipal address as properties of architectural and historical value and interest under Part IV of The Ontario Heritzge Act, 1974, S.O. Chapter 122.

(ā) 37 Colborne St. - exterior walls and clock tower

Although only 44 years old it is an important visual focus on the main street of Fenelon Falls. The Clock Tower is an important visual landmark and the village would be radically altered if at any time the tower or the building itself was removed. Few other towns in the area have clock towers. This building should be protected so that in future generations the OLD POST OFFICE can be enjoyed as part of the heritage of Fenelon Falls.

 (b) 94 Francis St., W. - formerly Anglican Parsonagethe exterior walls, front door and entrance facing Francis St., W.
Date of construction 1839-1840. The second oldest building in Fenelon Falls. The walls are built of planks from the first saw mill in Fenelon Falls

- (b) and one of perhaps only a few buildings with this type of construction. Although this home has survived fire damage it should be protected as part of the heritage of Fenelon Falls.
- (c) 72 Francis St., W. the complete Gazebo. Date of construction 1904. To-day such a building would either be pre fabricated or made of more portable canvass, therefore the gazebo on Francis St., W., is an important part of Fenelon's heritage. To find a gazebo in such good repair and with so many fine details is rare and a real benefit to the Village. The Gazebo should be protected as part of the heritage of Fenelon Falls.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Village of Fenelon Falls before the 30th day of March, 1981.
