By-law No. L.S.P.-3266-270

A by-law to designate 925 Dufferin Avenue to be of historic and architectural value.

WHEREAS pursuant to the Ontario Heritage Act, R.S.O. 1990, c. 0.18, the Council of a municipality may by by-law designate a property including buildings and structures thereon to be of historic or architectural value or interest;

AND WHEREAS notice of intention to so designate the property known as 925 Dufferin Avenue has been duly published and served and no notice of objection to such designation has been received;

The Municipal Council of The Corporation of the City of London enacts as follows:

- 1. There is designated as being of historic and architectural value or interest, the real property at 925 Dufferin Avenue, more particularly described in Schedule "A" hereto, for the reasons set out in Schedule "B" hereto.
- 2. The City Clerk is authorized to cause a copy of this by-law to be registered upon the title to the property described in Schedule "A" hereto in the proper Land Registry Office.
- 3. The City Clerk is authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in the London Free Press, and to enter the description of the aforesaid property, the name and address of its registered owner, and short reasons for its designation in the Register of all properties designated under the *Ontario Heritage Act*.
- 4. This by-law comes into force on the day it is passed.

SCHEDULE "B"

To By-law No. L.S.P.-3266-270

ARCHITECTURAL REASONS:

This one and a half white brick house with side hall plan has a decorative bargeboard and brackets under decorated front end gable. The porch is a later addition.

HISTORICAL REASONS:

This house has been home to working class residents for a century. Early home owners included John C. Beattie, a car builder; Oliver Dores, a traveller with London Tobacco Co. and Norval K. Wanless, an Assistant Storekeeper at the London Insane Asylum.
