BY-LAW NUMBER 89-52

Being a by-law to repeal By-Law No. 84-54 respecting the designation of the Property at 90 Main Street East, Huntsville of Architectural value or interest.

WHEREAS pursuant to Subsection 32(1) of the Ontario Heritage Act, the owner of the property known municipally as 90 Main Street East, Huntsville, has applied to the Council of the Corporation to repeal By-Law No. 84-54;

AND WHEREAS The Council of the Corporation, at its meeting held on April 10th, 1989, consented to the application of the owner as set out in Clause 26 of Neighbourhoods Committee Report No. 1;

THEREFORE the Council of The Corporation of the Town of Huntsville enacts as follows:

- (1) By-Law No. 84-54, being "A By-Law to designate the property at 90 Main Street East, Huntsville of architectural value or interest.", is hereby repealed insofar as it applies to the lands more particularly described in Schedule "A" annexed hereto.
- (2) The Town Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" annexed hereto in the proper land registry office.
- (3) The Town Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause a notice of this by-law to be published in a newspaper having general circulation in the Town of Huntsville, and cause the reference to the property to be deleted from the Register referred to in subsection 27(1) of the Ontario Heritage Act.

READ a first time this 10th day of April A.D., 1989.
