
Dear Ms. Semande:

Please be advised that the following recommendations were adopted by the Corporation of Haldimand County Council on March 6, 2017.

1. THAT Report PED-COM-03-2017 Request to Repeal Heritage Designation By-law 445/84 Gore School be received;
2. AND THAT the request to repeal By-law 445/84 for the property known as the Gore School, S.S.#7, located at 699 Haldimand Road 9, Hagersville (Part of Lot 24 Concession 2 Oneida, being Part 2, 18R7003), pursuant to Section 32 of the *Ontario Heritage Act*, be approved;
3. AND THAT notice of intention to repeal By-law 445/84 be provided in accordance with Section 32 of the *Ontario Heritage Act*;
4. AND THAT if no objections to the request to repeal By-law 445/84 are submitted, a repealing by-law be presented for enactment;
5. AND THAT if any objections to the repeal of By-law 445/84 are submitted, staff be authorized to take the necessary action to refer the matter to the Conservation Review Board.

Hearing no objection, the Church will be notified of the repealing of By-Law 445/84.

**NOTICE OF INTENTION TO REPEAL DESIGNATING BY-LAW NO. By-law 445/84
PURSUANT TO THE PROVISIONS OF SECTION 32 OF THE ONTARIO HERITAGE ACT
R.S.O. 1990.**

TAKE NOTICE that the Council of the Corporation of Haldimand County is giving its Notice of Intention to REPEAL By-law Number By-law 445/84, a by-law which designates the Gore School, 699 Haldimand Road 9, Hagersville, as a property of cultural heritage value and interest. Council approved the request of the owners to repeal the by-law at its March 6th, 2017, Council Meeting.

EXPLANATION OF THE REPEAL Haldimand County Council approved the request of the owners to repeal on the basis that the building's overall condition was deteriorated to such a state that it is not financially viable to restore the building.

APPEAL TO THE CONSERVATION REVIEW BOARD Any member of the public may appeal the repeal of this by-law to the Conservation Review Board by filing a notice of appeal, setting out the reasons for the appeal, with the Clerk of the Corporation of Haldimand County, within 30 days of the publication of the notice in the local newspaper.

Any objections to this repeal of By-law 445/84 must be filed no later than April 14th, 2017. Objections should be directed to the Clerk, Haldimand County, 45 Munsee Street North, P.O. Box 400, Cayuga, ON, N0A 1E0

The decision of the Haldimand County Council is final if an appeal is not received on or before April 14th, 2017.
