### CORPORATION OF THE TOWN OF NEWMARKET

## BY-LAW NUMBER 2003-56

A BY-LAW TO DESIGNATE THE PROPERTY, INCLUDING LANDS AND GRAVE MARKERS, KNOWN AS THE EAGLE STREET CEMETERY, AS BEING OF HISTORICAL SIGNIFICANCE.

(North side of Eagle Street, Lot 87, Plan 81, formerly in the Township of Whitchurch, Town of Newmarket).

WHEREAS Section 29 of the Ontario Heritage Act 1990 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value of interest;

AND WHEREAS the Council of the Corporation of the Town of Newmarket has caused to be served upon The Ontario Heritage Foundation, notice of Intention to so designate the aforesaid real property and has caused such notice of Intention to be published in a newspaper having general circulation in the municipality;

THEREFORE BE IT ENACTED by the Municipal Council of the Corporation of the Town of Newmarket as follows:

- THAT the land and grave markers located on the real property located on the north side of Eagle Street, Lot 87, Plan 81 (formerly in the Township of Whitchurch) in the Town of Newmarket, more particularly described in Schedule "A" hereto are designated as being of historical value or interest;
- AND THAT the reasons for designation of the land and grave markers located on the north side of Eagle Street, Lot 87, Plan 81 (formerly in the Township of Whitchurch), Town of Newmarket, are described in Schedule "B" hereto;
- AND THAT the Municipal Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper land registry office;
- 4. AND THAT the Clerk is hereby authorized to cause a copy of this by-law to be served on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in a newspaper having general circulation in the municipality.

# EAGLE STREET CEMETERY North Side of Eagle Street, Town of Newmarket

## LONG STATEMENT OF REASONS FOR DESIGNATION

The Eagle Street Cemetery site, occupying a slight rise on the north side of Eagle Street, contains the remains of at least 120 of Newmarket's early pioneers, some of whom were prominent in the establishment of our Town. The earliest verifiable burial is that of Eli Beman in 1820. The fact that he was buried on land which he owned at the time suggests that this site began as a family plot. However, within the same decade a number of others from the Church of England were also buried there. Thus, it became a public cemetery.

The present parcel was separated from the rest of the original 40 acres in 1863, and was deeded to St. Paul's Anglican Church for the sum of \$1.00. It continued to be used under the direction of St. Paul's, though its use declined after the opening of the Newmarket Cemetery in 1869. It is possible that the site was becoming filled up. Some burials were made as late as the early 1900's.

By the 1940's the grounds were overgrown and the grave markers in poor repair. Under the guidance of Canon Rhodes in 1947, the grounds were cleared and new calrns built to support the broken and damaged tombstones.

Today, it is very difficult to assess the original locations of the graves due to the restoration project of 1947. There is evidence to support the fact that some early settlers were buried very near to the entrance of the cemetery. No mention is made of any remains being relocated from their original resting places. The grounds are fenced in on all four sides, with a main entrance off of Eagle Street, and a pathway on the north side.

A historical plaque was erected by the Newmarket Historical Society and St. Paul's in 1979, and is located close to the south-west corner of the site, facing Eagle Street.

The Eagle Street Cemetery continued to provide a tangible link to Newmarket's past, and is worthy of designation for its historic value.
