CORPORATION OF THE TOWN OF NEWMARKET

BY-LAW NUMBER 2008-44

A BY-LAW TO DESIGNATE A PROPERTY AS BEING OF ARCHITECTURAL AND HISTORICAL VALUE OR INTEREST. (Hicksite Burial Ground – 16580 Yonge Street)

WHEREAS Section 29 of the *Ontario Heritage Act R.S.O. 1990* authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value or interest;

AND WHEREAS the Council of the Corporation of the Town of Newmarket has caused to be served on the owner of the lands and premises of Part of Lot 89 Con. 1, (formerly in the Township of King) and Part of Lot 90 Con. 1 (formerly in the Township of King) as in 0Y7655 and K12273 save and except R521284 and 1F90 being all of PIN 03626-0088, Town of Newmarket, Regional Municipality of York, known as 16580 Yonge Street, and upon the Ontario Heritage Trust, notice of intention to designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having general circulation in the municipality for two consecutive weeks.

THEREFORE BE IT ENACTED by the Municipal Council of the Corporation of the Town of Newmarket as follows:

- THAT there is designated as being of architectural and historical value or interest the real property described in Schedule "A" attached, comprising the footprint of the buildings described in Schedule "B" attached;
- 2. AND THAT the reasons for designation of Part of Lot 89 Conc. 1, (formerly in the Township of King) and Part of Lot 90 Conc. 1 (formerly in the Township of King) as in 0Y7655 and K12273 save and except R521284 and 1F90 being all of PIN 03626-0088 Town of Newmarket, Regional Municipality of York, known as 16580 Yonge Street, are described in Schedule "B" hereto;
- 3. AND THAT the Municipal Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper land registry office;
- 4. AND THAT the Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Trust and to cause notice of the passing of this by-law to be published in a newspaper having general circulation in the municipality for two consecutive weeks.

Part of Lot 89 Con. 1, (formerly in the Township of King) and Part of Lot 90 Con. 1 (formerly in the Township of King) as in 0Y7655 and K12273 save and except R521284 and 1F90 being all of PIN 03626-0088 Town of Newmarket, Regional Municipality of York, known as 16580 Yonge Street.

SCHEDULE "B" TO BY-LAW 2008-44

RÉASONS FOR PROPOSED DESIGNATION

The Hicksite Burial Ground located at 16580 Yonge Street is significant for architectural and historical reasons. The Meeting House and Burial site was established in 1830 by a group of the Society of Friends, (Quakers). The purpose of this designation is to designate that portion of property not currently identified within the designating By-law 1985-54.
