I advise the notice herein was sent by Registered mail on January 24, 2008.

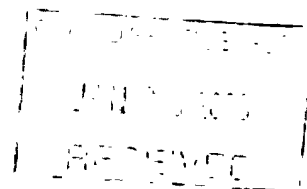

NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Newmarket intends to designate the lands known as 16580 Yonge Street – Part of Lot 89 Conc. 1, King and Part of Lot 90 Conc. 1 King as in OY7655 and K12273 save and except R521284 and 1F90 being all of PIN 03626-0088, Town of Newmarket, Regional Municipality of York.

REASONS FOR PROPOSED DESIGNATION

The Hicksite Burial Ground located at 16580 Yonge Street is significant for architectural and historical reasons. The Meeting House and Burial site was established in 1830 by a group of the Society of Friends, (Quakers) and used until 1920. The purpose of this designation is to designate that portion of property not currently identified within the designating By-law 1985-54.

The file which includes the complete lot description is available for viewing at the Clerk's Department, Municipal Offices, 395 Mulock Drive, Newmarket, Ontario.

Notice of Objection to the designation may be served on the Clerk within thirty days of the first date of this publication.
