





NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Newmarket intends to designate the lands municipally known as 336 Millard Avenue, being Part Lots 5 and 6, Plan 55 and Part Lot 40 Plan 31, Town of Newmarket in the Regional Municipality of York, in the Province of Ontario as in R208572.

REASONS FOR PROPOSED DESIGNATION

The home located at 336 Millard Avenue is an example of residential Edwardian Architecture in Newmarket built in 1910 by a local prosperous leading building contractor and occupied as his residence until his death in the early 1940's.
