

TAKE NOTICE that the Council of The Corporation of the City of
Barrie intends to designate the properties, including lands and
buildings, at the following municipal addresses as properties
of architectural and/or historical value or interest under
Part IV of The Ontario Heritage Act, 1974, S.O. Chapter 122:

(a) 126 Blake Street, Barrie, Ontario

Reasons for Proposed Designation

The property at 126 Blake Street was built between 1849
and 1856 as a residence for the first headmaster of the
Barrie Grammar School. The building was first used as a
residence for out-of-town boarders at the school. The rear
portion of the building was added at the turn of the century
by the owner at that time, Annie Laidlaw. The building was
one of the first houses built on Blake Street and one of
the oldest remaining houses built in the City of Barrie.
It is of classic country Georgian design, and one of the
very few remaining in the City of Barrie. It is a good

example of the style. Very few houses which date back to the early half of the 19th Century remain in the County of Simcoe.

(b) 17 Peel Street, Barrie, Ontario

Reasons for Proposed Designation

The house at 17 Peel Street is proposed for designation on architectural grounds. It was built circa 1867 by Royal Engineer, Shearman Bird, as home for Bird and his Chinese wife. Unquestionably unique in architectural character, this stucco house, originally painted strawberry red, shows Chinese architectural influences in the wood spires on the eaves and the pagoda-like bay windows and wood porch.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of The Corporation of the City of Barrie before the 1st day of September, 1978.
