Clause 12, Report No. 52, 1981

BY-LAW NO. 81-144

A BY-LAW TO DESIGNATE PROPERTY AT 678 KING STREET WEST AS BEING OF HISTORIC VALUE OR INTEREST, PURSUANT TO THE PROVISIONS OF THE ONTARIO HERITAGE ACT, 1974

PASSED: May 11, 1981

WHEREAS Section 29 of <u>The Ontario Heritage Act, 1974</u> authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest;

AND WHEREAS the Council of The Corporation of the City of Kingston has caused to be served on the owners of the lands and premises known as 678 King Street West and upon The Ontario Heritage Foundation notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the Whig-Standard on December 3, 1979, December 10, 1979 and December 17, 1979;

AND WHEREAS the Conservation Review Board has held a hearing to determine whether the property in question should be designated and reported its findings of fact and recommendations to the Council;

AND WHEREAS the Conservation Review Board recommended that the property known municipally as 678 King Street West be designated as being of historic value or interest;

AND WHEREAS Council has considered the report of the Conservation Review Board;

THEREFORE the Council of The Corporation of the City of Kingston enacts as follows:

 There is designated as being of historic value or interest the real property known municipally as 678 King Street West, more particularly described in Schedule "A" attached hereto.

The City Solicitor is hereby authorized to cause a copy of 2. this by-law and the reasons for designation to be registered against the property described in Schedule "A" hereto in the Registry Office at Kingston, Ontario.

3. The City Clerk is hereby authorized to cause a copy of this by-law to be served by registered mail on the owners of the property described in Schedule "A" hereto and on The Ontaric Heritage Foundation, and to cause notice of the passing of this by-law to be published in the Whig-Standard once for each of three consecutive weeks.

4. This by-law shall come into force and take effect on its passing.
