BY-LAW NO. 82-119

A BY-LAW TO AMEND BY-LAW NO. 8497, "A BY-LAW TO DESIGNATE CERTAIN PROPERTIES WITHIN THE MUNICIPALITY AS BEING OF HISTORICAL OR ARCHITECTURAL VALUE OR INTEREST"

PASSED: June 21, 1982

WHEREAS the property known municipally as 46 Sydenham Street was previously designated under the Ontario Heritage Act through By-Law No. 8497 registered in the Registry Office for the Registry Division of Kingston on October 13, 1976, as Instrument No. 282443;

AND WHEREAS By-Law No. 8497 correctly identified the municipal address as being 46 Sydenham Street, but contained an error in the legal description of the subject property;

AND WHEREAS the Council of The Corporation of the City of Kingston is now desirous of correcting the error in the legal description;

NOW THEREFORE the Council of The Corporation of the City of Kingston enacts as follows:

1. By-Law No. 8497 of The Corporation of the City of Kingston entitled "A By-Law to Designate Certain Properties Within the Municipality to be of Historic or Architectural Value or Interest" is hereby amended as follows:

A. Section 7 is hereby amended by deleting the following Subheadings and words:

"Description: All and singular that certain parcel or tract of land and premises situate, lying and being in the City of Kingston and County of Frontenac, and being more particularly described as Lots 35, 36, 37, 49, 50 and 51, Plan B-27, as described in Instrument No. 255812.

Owner: Rosemount Properties Ltd."

and by substituting therefor the following:

"Description: All and singular that certain parcel or tract of land and premises situate, lying and being in the City of Kingston and County of Frontenac and being more particularly described as All of Lot 48 on the North Side of Earl Street and Part of Lot 38 on the South Side of William Street, according to Plan B-27 for the City of Kingston, as described in Instrument No. 242277


