BY-LAW NO. 90-258

A BY-LAW TO DESIGNATE 148 BARRIE STREET OF HISTORIC AND ARCHITECTURAL VALUE OR INTEREST PURSUANT TO THE PROVISIONS OF THE ONTARIO HERITAGE ACT

PASSED October 2, 1990

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1980, Chapter 337 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historic value or interest;

AND WHEREAS notice of intention to designate 148 Barrie Street, in the City of Kingston, was served on the owners of the property and on the Ontario Heritage Foundation and was published in the Whig Standard on August 15, 1990, August 22, 1990 and August 29, 1990;

AND WHEREAS no notice of objection to the proposed designation was served on the Clerk of the City of Kingston;

NOW THEREFORE the Council of The Corporation of the City of Kingston enacts as follows:

1. 148 Barrie Street, in the City of Kingston, is hereby designated as being of architectural and historic value and interest pursuant to Section 29 of the Ontario Heritage Act.

I HEREBY CERTIFY THAT THIS IS A TRUE AND CORRECT COPY OF BY-LAW NO. 90-258, "A BY-LAW TO DESIGNATE 148 BARRIE STREET OF HISTORIC AND ARCHITECTURAL VALUE OR INTEREST PURSUANT TO THE PROVISIONS OF THE ONTARIO HERITAGE ACT", WHICH WAS PASSED BY THE COUNCIL OF THE CORPORATION OF THE CITY OF KINGSTON ON OCTOBER 2, 1990.

5. This By-Law shall come into force and take effect on its passing.

REASONS FOR DESIGNATION OF
148 BARRIE STREET, KINGSTON:

This 1877 tall, red brick residence sits on a high stone foundation and has a main storey bay window. Rising the full height of the building at the north corner is a quoined projection containing the tall, key stoned arched entryway. A wide frieze has moulded panels between pairs of brackets supporting the cornice of the bell cast, mansard roof which has flat roofed dormers.
