NOTICE OF INTENTION TO DESIGNATE

1. The Council of The Corporation of the City of Kingston intends to pass a by-law to designate the following property in the City of Kingston, County of Frontenac to be of historic and architectural value or interest, pursuant to Section 29 of the Ontario Heritage Act:

115 Gore Street

Lot 239 on Gore Street, Original Survey

Reasons for Designation:

This 1880 square, red brick, two storey house with twin chimneys has on its facade, windows set in detailed wooden surrounds. The architectural value of the building is enhanced by the later finely detailed entrance porch.

2. Any person interested may, within thirty (30) days after the date of this notice, send by registered mail or deliver to the Clerk of The Corporation of the City of Kingston notice of his or her objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts.
3. Where a notice of objection has been received, the Council of The Corporation of the City of Kingston shall refer the matter to the Conservation Review Board for a hearing and report.
