NOTICE OF INTENTION TO DESIGNATE

The Council of The Corporation of the City of Kingston intends to pass a by-law to designate **83 Earl Street**, in the City of Kingston, County of Frontenac, to be of historical value or interest, pursuant to Section 29 of the Ontario Heritage Act:

Reasons for Designation:

In 1843 Patrick McManaman signed a deed of partition with S. Muckleston and was assessed for a two-storey house and shop on this lot. He was a merchant who rented out four or five rooms on the upper floor. In 1851 he had this house plus a clothing shop on Brock Street.

This two-storey stone house has a hipped roof with a parapet on the east side where it abuts a later building. The central entrance has a wooden inset of pilasters supporting an arch with curved sunburst motif in the quadrants. The large flanking windows have rectangular transoms. Above are three windows under voussoirs which meet the cornice. The side has irregular fenestration and a single door.;

OBJECTIONS:

Any person wishing to object to this designation may do so by letter outlining reasons for the objection and other relevant information. These must be received by the Clerk of the City of Kingston either by registered mail or personally delivered by the **19th day of September, 1997**.
