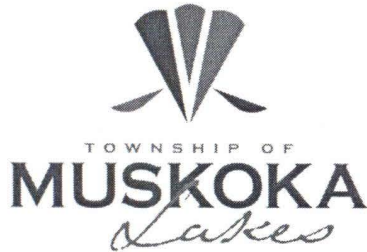

**THE CORPORATION OF THE TOWNSHIP OF MUSKOKA LAKES**

**BY-LAW 2013-54**

Being a By-law to designate the Property known municipally as the Shield Parking Lot, as being of cultural heritage value or interest

**WHEREAS** Section 29 of the Ontario Heritage Act, R.S.O. 1990, c.0.18 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of cultural heritage value or interest;

**AND WHEREAS** the Council of the Corporation of the Township of Muskoka Lakes has caused to be served on the owners of the lands and premises known as the Shield Parking Lot and upon the Ontario Heritage Trust, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having general circulation in the Municipality;

**AND WHEREAS** notices of objection to the proposed designation had been served on the Clerk of the Municipality;


**AND WHEREAS** a Hearing was convened under Section 29(8) of the Ontario Heritage Act, R.S.O. 1990, c.0.18, for the purpose of reporting to the Council of the Corporation of the Township of Muskoka Lakes, whether, in the opinion of the Conservation Review Board, on the basis of the evidence it heard, the property known as the Shield Parking Lot should be designated to be of cultural heritage value or interest.

**AND WHEREAS** based on the evidence heard, the Conservation Review Board in its decision dated March 13, 2013 agrees with the Corporation of the Township of Muskoka Lakes that cultural heritage value or interest as prescribed by Regulation 9/06: Criteria for Determining Cultural Heritage Value or Interest is found in the property known as the Shield Parking Lot.

**NOW THEREFORE** the Council of the Corporation of the Township of Muskoka Lakes enacts as follows:

1. The real property known as the Shield Parking Lot, more particularly described in Schedule "A" is hereby designated as being of cultural heritage value or interest for the reasons and heritage attributes set out in Schedule "B" to this by-law.
2. The municipal solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper Land Registry Office.
3. The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Trust and to cause notice of the passing of this by-law to be published in a newspaper having general circulation in the Municipality.
4. Schedules "A" and "B" attached hereto are hereby made part of this by-law.


