In the Matter of the *Ontario Heritage Act* Notice of Intent to Repeal Designation By-law 130-2012

The Ontario Heritage Act, R.S.O., 1990, Chapter 0.18 as amended, provides that the Municipal Council may pass a by-law to repeal a by-law designating property within the boundaries of the municipality deemed to be of cultural heritage value and interest. The Council of the Municipality of Chatham-Kent hereby gives Notice of Intent to repeal the by-law designating the following property:

Statement of the reason for the proposed repealing by-law:

The owner of 90 Park Street, Community of Chatham (City), applied to the Council of the Municipality of Chatham-Kent to repeal By-law 130-2012 designating the property. Council, at its meeting of March 20, 2017, by resolution, caused Notice of Intent to Repeal Designation By-law 130-2012 to be served on the owner, the Ontario Heritage Trust, and by general circulation in accordance with By-law 104-2014.
