

THE CORPORATION OF THE CITY OF OWEN SOUND

A BY-LAW TO DESIGNATE FIVE
PROPERTIES IN THE CITY OF OWEN
SOUND AS BEING OF ARCHITECTURAL
OR HISTORICAL VALUE OR INTEREST

WHEREAS Section 29 of The Ontario Heritage Act, RSO 1980, authorizes the Council of a Municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value or interest; and

WHEREAS the Council of the Corporation of the City of Owen Sound has caused to be served on the owners of the following lands and premises known as:

1. The Main Street Program Office
at 856/858 - 2nd Avenue East;
2. The Market Building
at 110-114 - 8th Street East;
3. Wray's Ladies Wear Department Store
at 966 - 2nd Avenue East;
4. The Whole Foods Store
at 941 - 2nd Avenue East; and
5. The Peoples Department Store
at 964 - 2nd Avenue East,

all in the City of Owen Sound and upon The Ontario Heritage Foundation, notice of intention to so designate portions or all of the said buildings and has caused such notice of intention to be published in the same newspaper having general circulation in the Municipality once for each of three consecutive weeks; and

WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Municipality.


NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF OWEN SOUND HEREBY ENACTS AS FOLLOWS:

1. The lands affected by this By-law are described in Schedules "A", "B", "C", "D" and "E" attached hereto.
2. There are designated as being of architectural value or interest, the exterior facades or parts thereof of the following buildings in the City of Owen Sound as follows:
 1. The front facade of the Main Street Program Office Building at 856/858 - 2nd Avenue East, more particularly described in Schedule "A" attached hereto. The reasons for designation are contained in Schedule "A-1", attached hereto.
 2. The upper portion of the front facade of the Wray's Ladies Wear Department Store building at 966 - 2nd Avenue East, more particularly described in Schedule "B" attached hereto. The reasons for designation are contained in Schedule "B-1" attached hereto.


3. The upper portion of the front facade of the Whole Foods Store building at 941 - 2nd Avenue East, more particularly described in Schedule "C" attached hereto. The reasons for designation are contained in Schedule "C-1" attached hereto.
4. The upper portion of the front facade of the former Peoples Department Store building at 964 - 2nd Avenue East, more particularly described in Schedule "D" attached hereto. The reasons for designation are contained in Schedule "D-1" attached hereto.
3. There is designated as being of historical value or interest the exterior facades of the Market Building known municipally as 110-114 - 8th Street East in the City of Owen Sound, more particularly described in Schedule "E" attached hereto. The reasons for designation are contained in Schedule "E-1" attached hereto.
4. The municipal solicitor is hereby authorized to cause a copy of this By-law to be registered against the properties affected by this By-law in the proper land registry office.
5. The Clerk is hereby authorized to cause a copy of this By-law to be served upon the owners of each of the properties affected by this By-law and on the Ontario Heritage Foundation and to cause notice of the passing of this By-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.
6. This By-law shall come into full force and effect upon the final passing thereof.
